Instead of responding to any of my questions or suggestions, he wrote again on 8/9/13:

Hi Sharon,

I have just read your updated page when your link the source of my real name to [kevingreen1950.wordpress.com](http://kevingreen1950.wordpress.com)

That blog was written by Janette Sharenborg and is purely a hate site, which is subject to both much ridicule and an ongoing police investigation as to it's personal content about people who merely question Janette Scharenborg's online activities.

As you have used that site as a point of reference for your 'conclusions' regarding myself being a 'Shill' I am afraid that I cannot see you as a credible truth seeker or indeed take anything you say seriously now.

You are welcome to put this email on your site as you did with the previous one, it may help to prove that at least one of your 'truths' is known to be an absolute lie..

The following is my email to him on 1<sup>st</sup> December 2015 re his socks:

Hello Jimmy,

As you know I'm looking into your socks. I've been looking at the site you call a 'hate site' <http://kevingreen1950.wordpress.com/2013/05/24/meet-royden-james-jones/> Incidentally, you cannot call it a 'hate' site when you have been given a platform to comment freely wherever you like. I have also been looking at Pride's Purge

From what I can see these sites are just hearsay and no substance. There is a minefield of disinfo, with claims and counterclaims being made left, right and centre. It seems to me that you are dishing out as good as what you're getting back, so you are hardly being 'victimised'. I would like to know who is telling the truth and who the liars are.

I am now going to give you the opportunity to convince me and the readers of my site that **you** are the one speaking the truth. I would therefore like you to answer some questions which I am going to put to you.

Before I go any further you claim that all your allegations can be easily checked and confirmed as they are all on public record. Well if you are keen to convince me and the public that you are the one telling the truth and that everyone else [including Scharenborg] are the liars, I would have thought that you would have been keen to provide the evidence and that it would already be on your 'Outlaw' site. But I don't see it there. In fact I don't see anything on your site pertaining to your allegations. I cannot find on any blog that you have contributed *any evidence to support anything you say*. You should not be expecting me and other researchers to have to search for verification of anything. The Courts/NWP would be no help anyway as such information is confidential. I wouldn't waste my time or theirs getting confirmation of that when you can easily provide the proof.

It is stated in the comments section here <http://kevingreen1950.wordpress.com/2014/07/20/gagging-for-attention-again-some-things-about-jon-that-might-interest-you/> that you were at Bryn Estyn for one month. Please confirm this is correct. If it is not correct, please state the length of time you were resident there.

I notice in your article here <http://outlawjimmy.com/2013/11/20/scallywag-revisited/> that your "recollections of the Bryn Estyn Children's Home were limited to say the least. The short time I spent there were mainly uneventful, tedious to the point of boredom as I recall. Any difficulties I encountered in the care system happened elsewhere, so the lurid tales of VIP Paedophile rings and systematic maltreatment were not in evidence during my brief stay." In your first email to me [dated 13/6/'13] you say that you are "**a survivor of CSA Childhood Abuse in the care system.**" Please clarify. Were you abused during your time in care, if so, what was the nature of that abuse and which home[s] did this occur?

Please provide evidence that you were in 'care'.

Did you give evidence at the Waterhouse inquiry?

Darren Lavery maintains that you are 'James', the man being interviewed by Channel 4 news here <http://www.channel4.com/news/exclusive-eyewitness-saw-thatcher-aide-take-boys-to-abuse> Kindly confirm if this is true. If it is, please show some proof that you were in contact with someone from Channel 4, such as a letter confirming the date of your interview.

In your email to Chris Spivey dated 22/1/'14, you say that Lavery "admits on camera to being an abuser of more than 20 'weaker' lads in care homes". I have watched all Lavery's videos; nowhere does he admit to that. Please reference this video and provide a link.

In your 13/9/14 email to me you say: "She [Scharenborg] has, with others made many, many false allegations against myself and my family, which are also being dealt with by the NWP. All can be checked and confirmed if you could be bothered to research simple facts." Please state exactly what these allegations are. Please provide the police documentation to substantiate your claims.

You also say: "Another fact is that one of Janette's troll mates Darren Lavery, who also made false allegations against me was recently convicted at Llandudno Magistrates Court for stalking and Harrassing my family. On the 24th of July I believe. As a matter of interest, he was arrested again on the 13th of this month by NWP at his address in Anglesey for publishing yet more lies and threats against me. Once again all a matter of public record and easily checked." Please detail these false allegations, and show the documentation re Lavery's conviction - I'm not interested in any newspaper cuttings; I want to see the court documentation. Please also provide the details and documentation in relation to his re-arrest.

You also say: "The attached images also shows an email that Scharenborg sent to somebody admitting she set up the Kevin Green 'The Man behind the Mask' blog, which you use a reference to quote from, and is one which both the North Wales Police and the Dutch police are in the process of trying to get removed. I notice she is now saying that it was not her, which is yet another lie." Please provide your correspondence with NWP and the Dutch police to back up your assertions.

You further state: “We have a solicitor acting on our behalf to stop this group of trolls from Harrassing, stalking and spreading malicious and libellous comments about myself and my family.” Please identify this solicitor and the firm, and show some letters from said solicitor to corroborate your claim.

Also: “Jane Russell is also a real person, she is not **my wife Helen**, who incidentally is in constant touch with both our solicitor and the NWP in regard to this campaign which you have now appeared to have joined.” I am trying to find out if she’s real. If she is she is obviously a very close friend of yours. Many say she is your sock. Everything points to that. I don’t suppose you could send me some I.D of hers, could you? You can easily scan and email her driving license/passport for example. If I was in your shoes [no pun intended] I’d be *proving* I had a friend called Jane. If you don’t send me this proof [or publish it on your website] I will take it as given that she is indeed your sock puppet, which means that ‘Jane’ is just another whopper of a lie that has come out of your mouth. The person who said she is your wife was Scharenborg.

There seems to be confusion as to the name of your wife. According to this email and your site it is Helen <http://outlawjimmy.com/tag/spivey/> According to this <http://kevingreen1950.wordpress.com/2013/11/18/ancestry-com/> dated 18/11/2013 her name is Katie. It is stated that other people who lived at the same property in *different* years is Helen C Jones. So it looks like Helen is your **ex**-wife? Care to clarify?

And: “Again, the NWP are only too aware that Jane Russell is a real person as she has also made a statement to them and a written one to her local force, regarding Scharenborg and Laverty's attacks on her. Again, all checkable and a matter of public record.” Care to provide evidence of that? As said you’re obviously very close to Jane, so I’m sure she won’t mind giving you a copy of her police statement, for you to scan and send to me... just to prove you’re not lying, you understand.

You add: “Where is your evidence that shows that my wife is in any way involved with this?” I didn’t mention your wife; Scharenborg did. Just to remind you, I said in Tom's comments section that this J Scharenborg told me in her 'confidential' email that she says of Jane Russell "who we now know to be Jones' wife". In any case **you’ve just told me in this email that Helen is very involved**, as she is “in constant touch with both our solicitor and the NWP in regard to this campaign”!!! Also **you** said

you and your family are being targeted; does that not include your wife? On your FB you say that “[This particular site was set up by the same people who have been stalking me for almost two years, sitting outside my house, taking photographs of my wife and children.](#)” Jimmy you keep tripping yourself up with your incessant lying.

And: “[I am also sending a copy of this email to our solicitor, the officer who is dealing with this current investigation in the North Wales Police and Sonia Poulton who is keeping a log of everything on my behalf.](#)” Good for Sonia Shill. Does the police officer have no name either?

Incidentally, you will be aware of Chris Spivey’s 7/8/15 article <http://chrisspivey.org/i-am-i-said/#more-28725> whereby he is making you look a right idiot saying, amongst other things, that Sonia Poulton is ‘Jane Russell’. Isn’t it time you exposed him for the thoroughly obnoxious liar he is, and provide the proof that ‘Jane’ is most certainly not Sonia.

Were you arrested in January 2014 for your cyber attacks on victims? If so please show the official documentation, and provide the outcome of any police investigation. According to Bloga land, you have recently [October 2015] been arrested and charged – under Section 127 of the Communications Act 2003. Please confirm this, give details of the offence, and provide the relevant paperwork.

You say that you were in Broadmoor and that the reason was “research”. <https://kevingreen1950.wordpress.com/2014/07/20/gagging-for-attention-again-some-things-about-jon-that-might-interest-you/> Please explain what you mean by this. Please also state how long you were there.

You state on 18/1/13 on the Kevin Green blog that JennieJenJen is your troll <https://kevingreen1950.wordpress.com/the-outlaw-jimmy-how-he-uses-his-blog-to-abuse-others/> But on 7/8/15 you provide a link to her blog <http://outlawjimmy.com/historical-revision/deus-vult/> Please tell us at what point she ceased to be your troll and why.

Finally are you going to confirm that your real name is Royden James Jones? [Back in September 2013 you told me you were too scared to reveal your identity.]

If your answers to these questions can convince me and my readers that you are NOT a shill, I will issue an unreserved public apology and will remove you forthwith from the hall of shame.

This is Jimmy's response [3 hours later!]:

Hi Sharon,

Thanks for your email, which I have read and had time to digest.

I can if required, immediately provide the evidence of around 95% of what you have asked me to provide to you in order for my name to be removed from your site, (the remaining 5% may take some time) however, I do not know you, know nothing about you other than the numerous claims that you are a crazy woman, nor have you given me any assurances that you will not publish any of the information on your site or elsewhere, should I provide such evidence to you in the first place.

To be honest, I could not care less whether I remain on your site being named as a villain or a saint, it has had no adverse effect on my life nor my families life, and the time I discussed it with Tom Cahill on Skype, I told him as much.

I will not, however, under any circumstances, be providing any evidence to you, nor anyone else in regard to the personal details of Jane Russell, as she is entitled to her privacy, ditto any details about my wife, who has had to change her name officially because she, along with myself have been stalked online and IRL since 2012 (we have the relevant Crime numbers to support these claims) and the follow up complaints that NWP have repeatedly failed to act on any of them - hence our file of IPCC complaints, (again for which I have the relevant paperwork should I choose to provide).

Why would you want to know the details of any abuse I suffered in the care system?

I have disclosed all I should ever wish to, to both Operation Goldfinch in 1997 and Operation Pallial in 2013, it is private and personal, not for public titillation, and the people who put their hands on me are now dead so it's pointless trying to pursue justice against them - in answer to your question, the 'abuse' I suffered, and which you referred to, did not occur at Bryn Estyn, but elsewhere in the card system.

I have NPC disclosures which provide the relevant dates of my

appearances at juvenile court and subsequent care order.

My care records are apparently being held by Operation Pallial until their investigations have been completed.

I am however, willing to show you the evidence you require if you are prepared to meet me and I will show you.

I will not be sending anything digitally because I cannot guarantee where or when it will turn up online.

I live in Wrexham, not that far from you in Colwyn Bay, I have nothing to fear nor to hide from, and yes, I am currently going through a court case - but it has nothing to do with attacking CSA victims - and again, I cannot discuss the details until it's concluded.

You really need to get your facts right before you ask about certain events you know nothing about other than you have read online or been spoon fed by God knows who Sharon.

I am responding to you as a courtesy only, as like I said earlier, I do not care one iota if what you have written about me remains in your site until the end of time, it's just lots of words on a screen, and far worse has been written about me and my family by people with a considerably larger audience than your site attracts - I will survive I am sure.

I will tell you one thing though, (and I have the marriage certificates to hand) I have been married twice, my first wife is named Katie and my second/current wife was named Helen.

Believing the tsunami of shit that pours from Scharenborg and her ilk online will really do you no favours if you want to be seen as anything other than a crazy person.

I look forward to your response if any.
