

MAGGIE TUTTLE written by SHARON ZAKI

We'd do well to question the sincerity of **Maggie Tuttle** [of the charity '[Children Screaming to be Heard](#)'] since she is closely associated with Sabine, [Belinda](#) and V/U, is promoted by [UK Column](#) and appears on videos made by [Eddythecat7](#) and the 'Truth and Hope' charity shills. [T & H](#) support the Hollie Greig saga and are sponsors for the controlled opposition 'UK End Child Abuse' rallies. They also support the VH story and have links to Sabine, J Hemming, B Gerrish... and of course they do lots of fundraising and have a donate button. Maggie says she has lost one of her own [her grandson] through foul play within the family court system. She could be lying about that. There is certainly no evidence to back up her story which is told by her good pal Sabine, linked [here](#). According to Sabine Maggie is being “gagged from talking to her MP” and “gagged by the court”. Well if what you say is the truth you cannot be gagged. So there's a lie for starters. Sure the masonic powers will try and put the frighteners on you to get you to STFU, but there are ways around that; see my story. Similarly Yannis Emmanouel says his daughter is in foster care. But he doesn't show any evidence of the corruption within the authorities/courts that led to her being fostered. If indeed she *is* being fostered, as there is no evidence for that either. He just makes vague statements like “A criminal judge force them 3 times to remove my child to teach me a lesson.”

The following is the email exchange I had with Maggie Tuttle December 2013/January 2014:

Before you make allegations just as the social services/workers do perhaps who ever is in the pockets of the social workers, but in my book to make up allegations of some one you know nothing of as you have done with my name I suggest you do as I have done for 40 years as a campaigner and brought changes of which one can only do with research and evidence I DO EXACTLY THAT but then in my forty years I am well aware that the British lazy race will use other peoples hard work to gain what ever, I learnt in the 70s to do all my self, and for your knowledge I am now 70 and in my day we were taught IF YOU WANT A JOB DONE DO IT YOUR SELF.I have bought and sold dilapidated property for 40 years to pay personally for all of my

campaigns which is many hundreds of thousands of pounds, SO do your research BEFORE YOU ACCUSE PEOPLE I have always dislikes the British and been ashamed of them most are no good caring people

Now leave me alone and let me get on BY MY SELF to fight for children's human rights

AND I SUGGEST YOU WHO EVER YOU ARE.START TO DO SOME GOOD WORK FOR THE CHILDREN

Hello Maggie,

You of course have a right of reply which will be published.

You say you don't know me; everything you need to know about me is in my website which you are obviously familiar with. However judging from your mail it is clear that you are not familiar with most of the contents of my site. If you were you would understand that no-one, especially a child, has any human rights whilst Freemasonry and other Secret Societies infect every body of authority worldwide.

You claim to be fighting for children's rights. Wild claims like "British lazy race" and "most are no good caring people" do not help. You are the one who needs to do some research. Maggie,

Your venom speaks volumes. As does your totally baseless accusations. You really are showing your true colours now.

Why can't you answer my questions? Instead you send me these troll-type emails in dribs and drabs every few hours or so! If you'd read [http://www.sharonkilby.co.uk/site/BEFORE\\_CONTACTING\\_ME\\_PLEASE\\_READ\\_THIS.php](http://www.sharonkilby.co.uk/site/BEFORE_CONTACTING_ME_PLEASE_READ_THIS.php) you'd see why I cannot attend to my emails as quickly as you'd like me to. You may have all the time in the world to fire off emails, but I don't.

You say that you are nothing to do with all the people I name and that you and Sabine never speak. Well that's at least an acknowledgement that you know what they do is wrong. You are not scared to challenge people in positions of power, such as Social Services officials, politicians; so why are you too scared to speak out against Sabine, Belinda et al? Why are you too scared to speak up for the sake of truth and justice - for Hollie and for the 22 wrongly accused of being

paedophiles and for the several wrongly named as being victims? How would you feel if your name was on that list of 22? You would be screaming from the rooftops about it and you would expect your fellow 'Truthers' to support you, and rightly so, because we all know that the police and courts cannot be relied on to deliver justice.

You tell me that you are not involved in the Hollie case, as if that is some sort of justification for your silence on the issue. I am really shocked that you as a campaigner for truth and justice and especially for children are not up in arms about the HG scam. I certainly am. Genuine victims of establishment corruption like myself do not want/need fabricated stories like the HG one muddying the waters and distracting from genuine cases. I was outraged when I found out that it is a hoax. I, like so many others, strongly supported the HG campaign as on the face of it the campaign was very worthwhile as the story very believable. Even though I was unable to be physically supportive due to time and financial restraints, I did what I could. I told everyone I came into contact with about the case, I highlighted it on my website, I wrote to Robert Green when he was in prison [and he replied] and I wrote to HDJ when it was Hollie's birthday, Nov '12. When it became a controversial subject I tried to help resolve the issue by trying to set up a debate between HDJ and HGH on Richplanet and elsewhere...

But it's not just the time wasted that bothers me [and not just my time but the time of all the other genuine 'truthers' whose time would have been better spent concentrating on helping the people who genuinely have been abused. Remember we are in a race against time. The NWO slavery agenda is real]. What is even more problematic is that the credibility of the 'Truth Movement' is now seriously weakened. That reflects on ALL of us. Credibility is EVERYTHING to a 'Truther'. Again I am shocked that a veteran campaigner such as yourself does not recognise this and therefore isn't bothered by it. Frankly I am surprised that I have to spell all this out to you. Can't you see that we 'truthers' cannot challenge Establishment corruption unless we have the evidence for it. It is imperative that we have our facts correct. Otherwise we all become a collective laughing stock **and can then be ignored**. In the case of Hollie Greig there is NO evidence that she was abused, let alone by a gang of paedophiles. There is therefore no cover up i.e no corruption at all with regards to Hollie; well not in the sense that the HDJ lot are trying to hoodwink us all with; and since you are obviously having difficulty keeping up I'm not going to try to explain what the actual, wider corruption is. Anyway, what we need to be doing now is helping Sylvia and Wyn and all the others who are wrongly accused find truth and

justice and also Hollie herself as she urgently needs to be rescued. That will go a long way to salvaging the credibility of the 'Truth Movement'.

You see when a fabricated story like the HG one hits the blogosphere and stays in our collective consciousness, it needs to be dealt with.

Otherwise the integrity of every single person who is screaming out about Establishment corruption i.e. the truthfulness of all of us 'Truthers' comes into question. I certainly don't want my reputation as a 'Truther' tarnished in this way because of some unscrupulous characters. Are you getting it yet? It is down to the genuine speakers of truth like you and me to do this. It can **only** be done by exposing the controlled opposition agents - people like Belinda, Sabine, Gerrish ...

Now, onto your video. I find it grossly insensitive because you have defiled graves that do not belong to you. You use random names, pretending that they belong to children and babies who have died in foster care and are buried in that cemetery. That's abhorrent. You have no idea who lies in those graves. If the families of whoever does lie there see that video and if they recognise the graves, they would be heartbroken. It was a member of my family who was watching the video with me who spotted that straightaway and was horrified. Having said that, the music itself is brilliant. Making tear-jerking videos is a pointless exercise anyway whilst there are agents of the State successfully suppressing truth

As I've repeatedly said, you will not help any of the children that you purport to care about until you help expose the people - the NWO gatekeepers - who suppress the truth.

As for your veiled threat of defamation, actually you have defamed me. I merely question your sincerity with a reasoned argument and it seems I was right to do so.

Now are you going to tell me that you are now on the side of the **genuine** truth tellers and are going to start putting your time and energy into exposing the Hollie Greig Hoax and the controlled opposition agents that I have named? Or are you going to continue to stay silent on the issue? If it's the latter it shows that you are a liar and a fake, a collaborator of criminals and a protector of paedophiles. Or then again, maybe you're just a coward and if that is the case, then you have 2 choices - lie down and let the NWO agenda play out and with that you will be condoning the suffering of children and their families or, and as I have said to Sabine and others, find Jesus and ask him to give you the courage to do what you know is right.

Let's take a closer look at the story of Maggie Tuttle's 'stolen' grandson. This story is told by Maggie's good friend Sabine ONLY. You'd think something of such importance such that Maggie [a seasoned campaigner for children for 40 years] lost her beloved grandson to foster parents would be written out **in detail on Maggie's own website**. Nope. Not a peep. The following is written by Sabine McNeill on <http://victimsunite.files.wordpress.com/2012/02/007-the-grandmother.pdf>

My comments are in red.

The Grandmother who Paid £25,000 in Vain to Free her Grandson from Abuse ]

Maggie Tuttle, nor anyone else, has provided evidence that she paid £1, let alone £25,000 to free her grandson from anything. Nor has she or anyone else provided evidence that he was abused.

#### 1. Nature of the Case / Background

Like many other grandparents, this grandmother has the interest of her grandson at heart, ever since he went to Social Services, to alert them of his mother abusing him. But, instead of the obvious move of letting the boy live with his grandmother, she was fooled by Social Services, when she was told that she can apply for a residence order or guardianship. She had to undergo a psychiatric test, along with many other assessments, including fire precautions in her home. After this intrusion into all aspects of personal life, she had to employ a legal team to represent her in secret family court hearings.

So the boy told social services his mother was abusing him? There is not one shred of evidence to prove that or that anything else stated in the above paragraph is true. Why doesn't Maggie publish the social services reports, 'At Risk' case conference reports, psychiatrist's reports, fire risk report, reports from all the other assessors, solicitor letters, court statements, court judgements ... ?

#### 2. Submissions of Fact

The grandmother has had a bond with the child since birth and he lived

with her for many months, while going through hell due to Social Services, CAFCASS and an army of professionals. He was given books on foster or adoption, was interviewed alone at least three times a week and was telephoned at school or Social Services offices. This child still is afraid of the abuser and continues to say no to contact with her. Yet the system says that this child is mentally disturbed for not wanting contact with his mother. Hence a top psychiatrist was brought in at great expense to give weekly therapy until such time the child agrees to have contact, as if he had never asked for help.

**Fact???** Don't make me laugh. This is all HEARSAY only. There is not one shred of evidence to prove anything stated above is true. Why doesn't Maggie publish the CAFCASS reports and the reports by the other professionals? Where is it stated in any official report that her grandson is "mentally disturbed"? What is the name of this "top psychiatrist"? What did the weekly sessions cost? How many sessions were there? Why doesn't Maggie publish this psychiatrist's report?

When the grandmother tried to protect the grandchild, he was torn away in front of witnesses with no warnings, along with lies and deceit, and contact with the child was stopped with more lies, leaving the boy alone with strangers, being moved from foster carer to foster carer, without family or friends, telephones, letters or any other child's right.

**BULLSHIT!** The only lies and deceit are the ones coming out of Sabine McNeill and Maggie Tuttle's lying mouths. Maggie Tuttle, name these 'witnesses' and these foster carers.

The grandmother was gagged by the court and not allowed to see any piece of paper relating to the case outside the lawyer's office. To receive a letter from Social Services, she has to pay the lawyer's fee to read it in his office. By now, the grandmother has paid in excess of £25.000 to be told: NO, the grandchild will remain with a foster carer.

**Provide the evidence Maggie Tuttle or be forever known as a proven liar. Lawyers hand or post documentation to their clients. To suggest that a lawyer would expect a client to read stuff in an office is just ludicrous.**

### 3. Points of Law and Procedure

In court, the grandmother never got to tell her side of the story, produce her evidence or was called to the witness box. For 8 days she listened to how bad a grandparent the child had. When she tried to speak out, she

was thrown out of court, with the judge stating “this is my court and you will abide by my rules.” The child was allowed to write one letter to his grandmother and in the few lines told her to stay strong.

The grandmother hasn't got any evidence because there was no case. None of the above happened. What's the name of the judge? What happened to the court order? Presumably Maggie was forced to read that in her solicitor's office too! Maggie Tuttle, you are a fool, an idiot, a joke and a bare faced LIAR.

**THERE IS NOT ONE SCRAP OF EVIDENCE TO SHOW THIS STORY IS TRUE.**

#### 4. Summary

Given these experiences, the grandmother is supportive of a newly created charity <http://www.childrenscreamingtobeheard.com/> so that children will have a voice and the charity will work to give children their human rights back.

There are hundreds of grandparents and families who have gagging order's placed on them by the courts. It appears that the courts do as the Social Services say, and that the word of Social Services counts more than that of the families who cannot protect their children/grandchildren. There are also many families serving long prison sentences as they had a gagging order but spoke out.

The British governments knows that our children are being stolen and sold, because stolen children are the 'consumer product' for foster carers, social workers, expert witnesses, contact centres, legal teams and court staff to support an industry well supported by the government with adoption targets and OFSTED ratings.

So, once again, we have more story-telling by Sabine but nothing to substantiate anything she says. In the case of Maggie Tuttle we have a story that not only fails to prove any corruption at all within the establishment, but, worse, it is a story that is devoid of *any* evidence that any of it is true.

**Warning:** Whenever you read something like 'submission of fact' on a shill site such as Maggie's, Sabine's ... you know very well that the 'information' provided is the **opposite** of fact i.e. it is a presentation of half truths and outright lies. Why should we believe anything the likes of Maggie Tuttle, John Hemming, Sabine McNeill and associates

say? These people are truth distorters i.e. BLATANT LIARS. Let's take a look at what Maggie says on her 'Conferences/Events' section of her 'charity' [L.O.L.]. My comments are in red.

We Invite you or any member of your organization to attend this seated and ticketed event.

There is no charge a donation to the registered charity is appreciated on the day all tickets can be collected on the day from a member of our team.

The aims of the conference is to which aims to prevent physical, emotional and sexual abuse and neglect of children by promoting the physical, emotional, and social well-being of children. We aim to promote the rights of children as citizens, through multi-disciplinary collaboration, education, campaigning and other appropriate activities.

1:-The fact is that parents who have committed no crime are losing their children to forced adoption!

This may be the case but Maggie and her pals have not provided evidence to support such a sweeping statement. They all publish **stories** that are NOT proven.

2:-Experts who depend on court appearances for a living, nearly always agree with the local authority. They make predictions that parents just might abuse their children (including newborn babies) in the future ,so these parents lose their children to permanent fostercare or adoption,not for something they have done but for something they might (or might not) do!

Another sweeping statement. I would like Maggie Tuttle to show me a case with EVIDENCE that a child has been taken from a parent for the sole reason that the parent *might* do something.

3:-Over 1000 UK children /month are taken into care ,Fosterers are paid

an average £400/week per child (birth mothers get around £20/week), and a foster agency founded by social workers getting around £1500/week per child was recently sold for £130million !A real money driven industry !!

I would like to see the **evidence** that over 1000 children in the UK are taken into care every month.

4:-Parents whose children have been taken are gagged and threatened with prison if they protest publicly;At contact parents are gagged again and forbidden to get emotional,to speak any foreign language,or to discuss the case with their children otherwise contact will be stopped.

Again another sweeping statement. I would like to see **evidence**. If you tell the truth you cannot be gagged in the UK. Sure, if the **masons** have got it in for you they will try to put the frighteners on you. But there are ways around it, for example, I was told not to 'coach' my children. I replied that I do not 'coach' them but that I do respond openly and honestly to my kids' questions and comments which is necessary for their sanity. See my story for more.

5:-More children are taken for emotional abuse than physical and sexual abuse added together.Despite "baby P" the number taken for physical abuse is steadily falling as a percentage of the total number of children taken.

Another sweeping statement. Evidence please!

6:-What are the solutions?

(a)Impose criminal rules of evidence in family courts so children cannot be taken unless parents are proved to have committed a crime affecting their children. Also parents would be free to obtain a second opinion from an expert of their own choosing.

**More rules are not needed.**

(b)Abolish all gagging of parents leaving them free to protest openly if their children are taken, and also to say what they like to them at contact without censorship ! Two very simple changes, two very obvious solutions.,but will anyone impose them and derail the money-train ?

**In the UK parents already have the freedom to protest openly and**

parents are also free to tell their children the truth.

The solutions are:

[a] to publish ONLY stories that are backed up with **verifiable evidence**.

[b] to expose ALL shills and fake victims and have them charged and brought to justice in a court of law.

[c] to outlaw all secret societies such as freemasonry and to charge and bring to justice all members who are guilty of any crimes.
