

RICHY [LAWFUL REBELLION] written by SHARON ZAKI

The following is in response to my 11/3/13 email that I sent to a number of people [which didn't include those already widely exposed as shills] in the 'alternative media' which states, "I have come to realise how dangerous the 'controlled opposition' are to Truth as they are so successful at thwarting the efforts of genuine NWO warriors. Shills and fake 'victims' are insidious creatures and more dangerous than a corrupt establishment. I believe the Hollie Greig story holds the key to revealing many shills currently prominent in the so-called 'Truth Movement'.

If you are not a shill, please will you respond asap and show me where on your site you are now publicly declaring that the the HG story is a hoax. Please also let me know what you intend to do to expose the shills/fake 'victims' and also whether or not you intend to do your level best to find out and expose who is *really* behind the Hollie Greig story and why."

**Richy** of Lawful Rebellion [which is endorsed by UK column and BCG and has close ties to TPUC] was at *first* happy to engage in a dialogue. **You can read our exchange of emails just below.**

On the 'Lawful Rebellion' website is the message: "STAND FOR WHAT IS RIGHT". Well it is clear that Richy of 'Lawful Rebellion' does not stand for what is right in the HG case and it is clear that he is not a real rebel. He thinks the HG story is 'dodgy' and has felt this way for over a year and yet he does nothing about it! He also refuses to expose Sabine and Belinda Shill. [He's *heard* they are shills, but he doesn't *know* that they are and he has no intention of finding out!]

People who won't expose the shills are either shills themselves or are too scared to speak out, and if it is the latter, they are not fit to be fighting on the front line or to even call themselves soldiers against the NWO. Half hearted rebels are *playing* at being soldiers and are no threat to the PTB. Those people might as well close down their websites, join the sheeple, watch the soaps, and let the NWO play out.

Richy has no desire to expose the HG hoax, therefore no desire to get to the truth behind that story and discover the bigger picture. Worse, he is friends with a vehement supporter of the HDJ campaign, Sandra Barr! She writes [this article](#) which reveals the very clever way the 'Hollie

Demands Justice' group operate. We can learn a lot from our enemies!

The following is an email exchange I had with Richy in March 2013. His comments are in green.

Hey Sharon

Was this a mass mailout or something? The fact that i've run [lawfulrebellion.org](http://lawfulrebellion.org) for over 4 years now, and before that ran TPUC.org with John Harris for 2 years should be sufficient enough evidence of my authenticity. Lawfulrebellion & TPUC are the real deal.

Yes i've been aware that the HG story was dodgy for at least a year, Im friends with Sandra Barr and she has filled me in. Sounds like a pit of vipers. Lawfulrebellion.org and TPUC.org never carried a single article on HG.

As for what I will / can do - if you offer compelling evidence and a solid, referenced article I will make it a featured story on [lawfulrebellion.org](http://lawfulrebellion.org) / facebook / twitter.

Hi Richy

Thanks again for your swift response.

Why won't you publish the fact that you know the HG story is a hoax? - Personal opinion is not fact, I have nothing more on the HG story. either way.

You say your offer is to post a solid article on it, but don't you think it would have more impact if the article came from you and reflected your opinion? Opinion has less weight than fact, you claim to be in possession of facts, so how about sending them on over rather than increasingly long emails?

Don't you think it is important for those 22 accused of being paedophiles [not to mention Hollie herself] that the truth is told? This is a dumb question. Yes if it's true it's important. So how about you offer me an article.

Just curious, I'm aware that 'Lawful Rebellion' is endorsed by the UK Column and the British Constitution Group; you are obviously aware that Brian Gerrish supports the HG story, what do you make of that? No idea, the options are he was either duped, in on it, or allowed it to be supported by UKC when he should have investigated further himself

Re Roger Hayes of the BCG I recollect hearing or reading somewhere that he, like you, believes the HG story is dodgy but he won't publish his opinion either. Would you know why that is [assuming that I have those facts right.] [I also wrote to Roger and await his reply.] No.

You don't mention Sabine and Belinda. Do you not agree that these shills need to be exposed? As I don't know if they are but rather I have only heard they are I cannot say. However, why don't you stop messing around and provide an article about them

You say John at TPUC won't be interested but I don't understand why; maybe if he knows you are going to publish your view, he might also? Nope. He's not publishing anything in the foreseeable future as far as I know.

I appreciate the fact you're busy, but if we're all serious about truth and justice for all and doing our bit to stop the NWO we need to make sure truth sees the light of day in the case of the HG affair too. Also it is down to us genuine Truthers to expose the NWO gatekeepers. You say you have limited knowledge on the HG case, well all the knowledge you need can be accessed easily on the HGH site and other sites. Fine. BUT - this does not change the offer. The article comes from someone with first hand knowledge and PROOF.

You're doing a great job with Lawful Rebellion, so too are John with TPUC and Roger with BCG. You all have a perfect opportunity to see that the truth re the HG affair reaches a wide audience. Incidentally I note what you say about John not dealing with the emails, but surely someone else at TPUC does so? Why don't you try and make contact with someone via the forum. I don't run TPUC.

The following is my final email to Richy dated 20/3/13 and his reply:

Dear Richy,

I appreciate you're busy but please will you give the HG issue some serious attention when you get time.

I know you asked me not to respond, however this needs to be said. Your tone tells me that you are not interested in determining the truth about the HG case.

There is an abundance of evidence that the HG story is a hoax, as detailed in all the links provided. [Incidentally I have not claimed to be in possession of facts as you stated. I have only referred you to the appropriate websites.] You have seen this evidence for yourself and you said yourself that you are aware the story is 'dodgy'. All I am asking you to do is state this publicly on your site. Why is this so difficult for you? Why will you not encourage your friends John Harris and Roger Hayes to do likewise? [I will again try to contact someone from TPUC and I will write again to Roger Hayes.] If you really cared about truth and justice for all, you would not be irritated with me for raising this issue, you'd be bothered by their nonchalance. The same goes for your blasé attitude towards Brian Gerrish. If you were a genuine 100% 'truther' you would not risk your own credibility by association with him. You would expose him instead. A half-hearted 'truther' is a pretender.

**Your Website states "Lawfulrebellion.org seeks to supply Audio Interviews, Articles and Videos from the People who are discovering the truth of our reality."** You keep saying your offer is to post a solid article on the matter from someone with first hand knowledge and proof. Your offer should be to help expose the truth re the Hollie affair. I really shouldn't have to spell this out. You should use your initiative and do a question and answer article or video with both the HDJ team and the HGH team or just the Hoax team if the others refuse.

If you were a real freedom fighter and you really cared about truth and justice for the 22 innocent people accused and Hollie herself [not to mention the several other so-called victims of this alleged paedo ring] you would be willing to do so; in fact you wouldn't need me to suggest it.

You would NOT be scornful and make such a remark as, "This is a dumb question. Yes if it's true it's important."

It's no good people like you knowing a story is 'dodgy' and not doing a damned thing about it. How would you feel if you were one of those 22 accused and none of your fellow A/M 'truthers' cared? Your inaction is just furthering their suffering. Sitting on the fence is a coward's way.

If you were a serious 'truther' you would be fuming that your friends John Harris and Roger Hayes are staying quiet on the matter. You know that the HDJ campaign went viral in no time in the UK and internationally. Don't you think it is only fair that the Hoax team got some exposure in the alternative media? You, John and Roger could shame all the other 'truthers' into action.

Re Sabine and Belinda Shill, you tell me to "stop messing around and provide an article about them". If you were a serious truther you would not be derogatory towards me; you would be looking at the evidence and exposing these traitors. I have already shown you the evidence.

If you were a real freedom fighter you would be as keen as I am to discover the bigger picture re the Hollie issue and you would also want to expose the shills.

This is an issue that isn't just going to go away; it needs some form of resolution. As a so-called 'truther' are you going to do your bit?

If you intend to remain passive on this issue I would urge you to think about how you're going to feel when x months/years down the road, when the truth is emerging and people start asking you why you did nothing.

Please stand up for what's right. Please show this email to the above named, including Gerrish and all your other contacts. Let them know that real freedom fighters speak out against injustice.
