

DMCA notices

In August 2018 there was another attempt by the freemasons via my website host Dave to shut me up. Here follows our email exchange under the subject title "copyright content on your web site":-

"Sharon

Please find below what I have received today. Could you please act on it ASAP.

Original report:

My name is Janette Scharenborg and I am the owner of the website timetostartcaring.com. A website that your company hosts named sharonkilby.co.uk (this according to WHOIS information) is infringing on several copyright owned by me.

This letter is an official notification under Section 512(c) of the **Digital Millennium Copyright Act ("DMCA")**, and I seek the removal of the aforementioned infringing material from your servers. I request that you immediately notify the infringer of this notice and inform them of their duty to remove the infringing material immediately, and notify them to cease any further posting of infringing material to your server in the future.

Please also be advised that law requires you, as a service provider, to remove or disable access to the infringing materials upon receiving this notice. **Under US law a service provider, such as yourself, enjoys immunity from a copyright lawsuit provided that you act with deliberate speed to investigate and rectify ongoing copyright infringement.** [My highlighting.] If service providers do not investigate and remove or

disable the infringing material this immunity is lost. Therefore, in order for you to remain immune from a copyright infringement action, you will need to investigate and ultimately remove or otherwise disable the infringing material from your servers with all due speed should the direct infringer, your client, not comply immediately.

I am providing this notice in good faith and with the reasonable belief that rights that I own are being infringed. Under penalty of perjury, I certify that the information contained in the notification is both true and accurate

I would like to add, I am a survivor of childhood sexual abuse, I write what I have been through as a child, this not only helps myself but helps so many others who, have suffered the same as me. Having this person judge my statements feels like I am being raped all over again. Please read the comments on my site. I work for an organization Together we Heal, it is a worldwide known organization for survivors of CSA (childhood sexual abuse) what do you think people will think if they google my name and find such nonsense? This is pure defamation of my good character.

In case your client is convinced there is no copyright infringement in this situation, please, ask her to submit an official DMCA counter notice. Otherwise, the content on the website should be removed or we will be forced to proceed with suspension of your server.

Are you able to act on this otherwise we would have to suspend the site until you do sorry.

Hi Dave,

When I first spoke to you about hosting my site I warned you that the enemy – the freemasons – would, sooner or later, threaten some sort of legal action, and I asked if you would be intimidated by that. You laughed and assured me that you would not. That told me that you were **independent**; that you **alone** were in a position to decide whether or not my site should be suspended/taken down for whatever reason. Now, it seems, that is not the case. So, who is this person from your data centre who is browbeating and insisting that I submit a DMCA counter notice? I can, of course, do so, but since you are not making this decision, I think I'm entitled to know who is insisting on one, lest my site be suspended. Also, please could you ask said person *how* the complainant found out that you are my host. I was not aware that such information is publically available.

The complaint of copyright violation is based on deliberate misreading of the law. As said the complainant is using copyright as a tool of censorship.

The material in question is not copyrighted; it is in the public domain and may be criticized/commented on by anyone, for and in the public interest.

My use of the material is legally protected because it falls within the "fair use" provision of the copyright regulations, as defined in [17 USC 107](#). If the complainant disagrees that this is fair use, she is free to take up the matter with me directly, in court. The ISP is under *no obligation to settle this dispute, or to take any action to restrict my speech at the behest of this complainant*. It is not true that "we will be forced to proceed with

suspension of your server". Furthermore, siding with the complainant in a manner that interferes with my lawful use of your facilities is unfair and unprofessional.

Its public knowledge to who owns domain names. Having my name servers for example on your web hosting means they can then google hosting click and then it comes back to me as a company.

I am 100% happy hosting anything that is not copyrighted or illegal. What I don't want to do is spend many hours or days or even weeks looking in to copyright infringement for a site I host. I wouldn't do this for someone who pays £4 or £4000 a month, it's just not my battle as such if I can use that word for a service I offer.

You can contact my data centre if you want to with the details below but **if it gets to the point they are going to pull 1 of my servers down I will have to suspend your site until they are happy it's not copyrighted [my highlighting]** and then I am 100% happy to keep it hosted. I can't have over 300 web sites go down because of this.

If it is 100% fine to have that content on your web site there is no reason why you can't do what they asked and then you will be allowed to keep it hosted?

My data centre is based in the UK but **the company is based in the U.S. [My highlighting.]** I am totally happy passing on the details for you to email them but what I don't want is them taking down all my servers while this continues. I would rather them and you battle this out and if the outcome is you win sure the site would be perfectly fine being hosted.

Please email Abuse@vps.net and make sure the subject on the email is this " Re: [#835865] Abuse reported on your VPS 82.163.73.92 " without the " " if the subject is wrong it won't get to the correct department.

I look forward to hearing from you asap regarding this. Also please forward me in on any emails sent to them.

Hi Dave

Freedom of speech is in serious jeopardy.

Thank you for this, and I do understand your position. I don't intend to contact your data centre – I have no wish to speak to bullies who side with fraudsters who work for the censorship brigade. I also do not want to cause you problems, such as the loss of one of your servers. I was merely asking for the name of the person who informed you that I must submit an official DMCA counter notice. Could you please forward me that email.

There is no freedom of speech when a web host can suspend a site just because of an *unsubstantiated* complaint whereby **not even a letter from a lawyer threatening legal action is required**; whereas the person being attacked by a *bogus* take-down notice is forced to submit to an 'agreement' which may involve having to mount a defence in the jurisdiction of the **USA**. What a joke that is. How is that in any way right and proper?

This DMCA notice is patently false and malicious and can be legally challenged under Section 512[f] – Fraudulent take-down notices. I will be looking into that – there may be a good copyright lawyer who is willing to help me out on a 'no win, no fee' basis.

In the meantime please ask Janette Scharenborg to specify the material that she says is copyrighted because most of the stuff that I have copy/pasted/commented on from her site are the comments that have been made by **members of the general public** [most of which in reality are comments made by trolls such as herself masquerading as Joe Public] in the comments section which she provides on all her articles. **Of her actual articles** I have copy/pasted just *one short paragraph* [see page 8 of my pdf <http://sharonkilby.co.uk/wp-content/uploads/2017/07/JANETTE-SCHARENORG.pdf>] *three short*

paragraphs [see page 17 of my pdf] and *one short paragraph* [see page 18 of my pdf]. As for the paragraph copied which is on page 19 of my pdf, that doesn't count because it is a re-blog. So I ask you, how in the world can that be considered a copyright violation? I will be happy to remove said paragraphs if I can have assurance that my site will not be suspended.

Everything you send to me will be passed on to the data centre for them to pass it on to the person who is questioning your content.

I am happy to be the middle person but that is all I will be in this case.

I am still happy to host you no matter what the outcome is but as stated above I will not host copyrighted or illegal content. If you are correct in what you are saying then you have nothing to worry about regarding this and your web site will stay the same and nothing will change. Totally out of my hands if the data centre take your web site down as they are not hosted at my office. They are hosted in London in a data centre where I have no access to other than remote access to my servers.

All this negative shit is having a nasty effect on my children and I am sure later on my grandchildren, you really dont know me, but one thing I can say to you, when I said police were busy with my case that was why I couldnt talk or show you anything about it, I had many ongoing cases with different forces, for as you know all those attacking me lived all around the country, I will now share with you certain things, but I want your promise you will not put these anywhere on the web, nor, will you share them with anybody else. So please give me your word before I send you certain things.

I am not on twitter or on any other platform anymore and have not been for the last two years, well since the birth of my first grandchild.
